

Terms of Use

By accessing and/or using *RIHA Journal*, you accept and agree to abide by the following Terms of Use:

1. Limited License. *RIHA Journal* consists of an electronic journal (www.riha-journal.org) containing Content. "Content" includes all articles, front matter, back matter, images, indexing, and other texts, graphics, and all other materials incorporated into *RIHA Journal*.
